What's Historic About this Site?

The Dahl House: The Last of Old Lowertown

Editor's Note: This is the first in a series of articles on Ramsey County's historic sites which will be published in forthcoming issues of Ramsey County History.

ne of the most unlikely of Ramsey County's historic sites, for those of us who think of them in terms of the mansions of the rich. is a one-story, stucco-covered cottage on the edge of the approach to the capitol. But the William Dahl house at 136 Thirteenth Street, deserves its listing on the National Register of Historic Places as the last surviving residence of the onceresidential Lowertown district.

William Dahl, who came to Minnesota Territory from England about 1849, was a man of several occupations. Early St. Paul records list him as a clerk, census taker, shopkeeper and general agent for the Hudson's Bay Company.

In 1857 Dahl purchased a lot on the edge of Lowertown and around the corner from the sturdy two-story stone structure fur trader Norman Kittson was building on Jackson between Twelfth and Thirteenth Streets. Dahl completed his wood frame Greek Rivival cottage the following summer. His contractor was Ireland and Donavan. The "Ireland" in the partnership was Richard Ireland. whose son, John, became the first archbishop of St. Paul.

The original Dahl house measured twenty by thirty feet with a low-pitched gable roof and a full basement. As the years passed, two additions were made to the house. The first, added around 1886, included a nineteen by sixteen-foot kitchen attached to the rear of the house. In 1962 a fifteen by sixteen-foot dining/recreation room was added to the kitchen and the entire structure was covered with stucco.

The main living rooms for William Dahl and his family were in the basement of their new home. Unheated sleeping quarters occupied the main floor. William lived there only a few months, however. He died of consumption in September, 1858, leaving his wife, Catherine, who was pregnant with their third child, to support the family. She did so by taking in washing.

The Dahls' only son, Edward, went into the furniture business at the age of 13 to help with the family's expenses, and he inherited the homestead when his mother died in 1901. By that time Edward had retired from the furniture business he had operated for twenty-five years and was devoting all of his time to serving as a secretary for the St. Paul Junior Pioneers. In 1889 he had been a founder of the Pioneers, a civic-minded group dedicated to supporting the city's development and preserving its heritage.

Edward and his wife, Sophia, lived in the house until the summer of 1936. when he sold it to Roy Patterson. The next year Edward died at the age of 81. The Pattersons remodeled the house extensively and raised their children there before Mrs. Patterson sold the property to the state of Minnesota after her husband's death. The state used the house as offices for the criminal system ombudsman. The house still stands as one of the last remaining reminders of St. Paul's pioneer past.

When Edward Dahl moved from his boyhood home in 1936, he recalled for a newspaper reporter some memories of the years when he and the city were growing up together:

"There's a lot of sentiment stored away in this house," he said. "Father died here and so did mother. . . . When I was a kid [in the 1860s], I used to pick hazel nuts up the hill yonder," he continued, pointing toward the state capitol, "and across Robert Street were the Tipperary flats. It was covered with shacks."

Kittson's house has long since been demolished, as have all of the other homes that once graced Lowertown, but the home that William Dahl built for his family 132 years ago expresses the lifestyle of the common folk of that period.
